ORDER


This Order is being issued in continuation to this Office Order No. SLN/Reader/DM/1-14/89-IV-7787 dated 6th July, 2020, vide which following areas was notified as "CONTAINMENT ZONE", viz; (1) Sweet Industry Unit-I and II located at plot No. 17 and 18, Sector-1, Parwanoo, shall be closed and roads leading to these units, (already was de-notified vide this office order No. 7989 dated 10th July 2020) (2) House No. - 124 & Complex of COVID-19 positive patient in Ward No.-4 Ucha Panchayat Taksal, (3) House of COVID-19 positive patient of Ward No.-12, Gram Panchayat Taksal and lane from Ramesh House to Vijay House, (4) House of COVID-19 patient and three adjoining house and path leading to the houses at Village Nalwa Gram Panchayat Kasauli-Garkhal, by the undersigned.

WHEREAS, the Executive Magistrate- cum- Assistant Commissioner (Parwanoo), District Solan, vide letter No. Asstt./**(COVID-19)Part-II/2020-3432** dated 13th July, 2020 has reported to the undersigned that exercise of door to door screening of persons for SARI/Flu like symptoms and extensive contact tracing (backward & forward) were conducted in containment zone and adjoining area by the health authorities. It was further reported that the COVID-19 test results of the direct contacts and random sampling of sizeable population from these areas have been found to be **negative** and also no new case of COVID-19 has been detected or identified, therefore, requested to de-notify the containment area as no new case COVID-19 has been found in the vicinity of above-mentioned areas during the containment period and such the containment of these areas are not required to be continued.

Solan District Solan (IAS), District Magistrate, Solan (H.P) do hereby declares/de-notified that the rest of areas of Containment Zone, i.e. (1) House No. - 124 & Complex of COVID-19 positive patient in Ward No.-4 Ucha Panchayat Taksal, (2) House of COVID-19 positive patient of Ward No.-12, Gram Panchayat Taksal and lane from Ramesh House to Vijay House, (3) House of COVID-19 patient and three adjoining house and path leading to the houses at Village Nalwa Gram Panchayat Kasauli-Garkhal, Tehsil Kasauli, Sub Division Solan, District Solan HP now ceased to be containment zones. Hence, the restrictions imposed in these areas vide Order No. SLN/Reader/DM/1-14/89-IV-7787 dated 6th July, 2020 shall no longer remain in force. It is further ordered that the Order dated 5th July 2020, issued by the undersigned shall remain continued to be applicable in these areas.

Rest of the conditions is applicable in the entire District shall remain in force in the above released zones.

This order shall come into force with immediate effect, till further orders.
