**ORDER**

This Order is being issued in continuation to this Office Order No. SLN/Reader/DM/1-14/89-IV-9370 dated 31<sup>st</sup> July, 2020 vide which the undersigned has withdrawn midnight curfew in this District and further, it has also been clarified that the regulations/SOPs issued by the Chairperson, State Executive Committee (SEC) and by this office from time to time shall also remain in force.

**Whereas**, the Chief Secretary-cum-Chairperson, State Executive Committee (SEC) Himachal Pradesh, vide Order No. Rev. (DMC) (C) 20-2/2020-COVID-19 dated 28<sup>th</sup> August, 2020 has issued the directions in continuation of State Executive Committee Order No. Rev (DMC) (C) 20-2/2020-COVID-19 dated 31<sup>st</sup> July, 2020 in exercise of the powers conferred under the Section 24 of the DM Act, 2005 in capacity of the Chairman; State Executive Committee (SEC) vide which some amendments have been done by the Department and direct all the Departments & Organizations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State to ensure strict implementation of the directions of the SEC.

**Now, therefore**, keeping in view the directions issued on 28<sup>th</sup> August, 2020 by the Chief Secretary-cum-Chairperson, State Executive Committee, Himachal Pradesh, I, K.C. Chaman, (IAS) District Magistrate, Solan (Himachal Pradesh) do hereby order that the following amendments shall remain in force in this District till further orders as hereunder:-

**Amendments**

**6. Quarantine requirements,**

**Point No. (xv) & (xvi) will stand modified as under:-**

**Point No. (xv)-**

The tourists with valid booking, for durations not less than 2 nights, either at a single location or multiple locations, and having been tested negative for COVID-19 through RT-PCR (Reverse Transcription Polymerase Chain Reaction), TRUNAT or CB NAAT test by an ICMR accredited/approved laboratory, not earlier than 96 hours at the time of entry at State Borders, may also be exempted from the requirement of quarantine. Children under the age of 10 year will not need any COVID-19 test if the accompanying adults have a COVID-19 negative report. However, he/she will take adequate precautionary measure like wearing of mask, social distancing, etc. to prevent spread of COVID-19.

**Point No. (xvi)-**


Any person having been tested negative for COVID-19 through RT-PCR Test (Reverse Transcription Polymerase Chain Reaction), TRUNAT or CB NAAT test by an ICMR accredited/approved laboratory not earlier than 96 hours at the time of entry at State Border may also be exempted from the requirement of quarantine. However, he/she will take adequate precautionary measures like wearing of mask, social distancing, etc. to prevent spread of COVID-19.

**10. Penal Provisions:-**The Section 199 may be read as Section 188 of IPC.

**NOTE: -**

Rest of the conditions shall remain unchanged.

This order shall come into force with immediate effect, till further orders.
