"ORDER UNDER SECTION 144 Cr.PC."

Whereas, it has been brought into the notice of the undersigned by the Health Authorities that few positive cases of COVID-19 has been found in **Mohan Colony, Ward No 5 of Municipal Council Solan, Tehsil Solan, District Solan**. Therefore, there is an eminent danger of spread of COVID-19 in the other parts of Sub Division Solan and District Solan and to take strict measures to stop the further spread of COVID-19, it has become inevitable, to take action, which if not taken immediately can endanger human life and safety.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed under Section 144 of The Code of Criminal Procedure, 1973.

And, therefore, in view of the above circumstances and as a containment measure I, Ajay Kumar Yadav, I.A.S., Sub-Divisional Magistrate, Sub- Division Solan, District Solan (Himachal Pradesh), in exercise of the power vested in me under Section 144(1) of The Code of Criminal Procedure, 1973, do hereby order and declare the complete sealing of following area of Sub Division Solan, District Solan H.P. as **Micro-containment** zone in the following manner:-

Name of Sub Division	Micro-Containment Zone
SOLAN	House No. 14/6 of Sh. Raj Kumar, Mohan Colony, WARD No.-5, Municipal Council Solan.

It is further ordered that:-

1. UNDER NO CIRCUMSTANCES SHALL THERE BE ANY INGRESS/EGRESS OF ANY PERSON OR VEHICLE IN THE CONTAINMENT ZONE, except for persons/vehicle involved in enforcement of containment plan, essential services and medical emergency.
2. The supplies of essential goods in the containment zone shall be done by the authorities through Home delivery.
3. No. person shall leave their homes on foot or through vehicle or travel or move around, roam around or stand on any public path or place in the aforementioned containment zone.

This order shall come into effect immediately for the entire area of above mentioned containment zone and shall remain in force till further orders.

Any violation of this order will attract provisions of Section 188 of Indian Penal Code and the violator can also be prosecuted under section 269 and 270 of Indian Penal Code.


