ORDER

WHEREAS, the issuance of unlock 5.0 guidelines have resulted to opening of various activities in District Solan in pursuance of these guidelines, the Tourism Sector, Colleges/Schools and industrial activities have started functioning to its capacity, which necessitates issuance of guidelines regarding COVID-19, Sampling/Testing, so that the spreading of COVID-19 infection among public in large could be contained.

NOW, THEREFORE, in view of the above mentioned facts and circumstances, I, K.C. Chaman, IAS, District Magistrate-cum-Chairman District Disaster Management Authority, District Solan do hereby order that it shall be mandatory for the management of Hotels/Restaurants, Educational and Industries to get the Corona Test of its employees done before re-joining of their staff. Similarly primary contacts of the COVID positive cases will also made themselves available for sample lifting without fail. In Case any flu/symptoms in any staff member than the same facts shall be reported to the District Health Authorities Solan. In the eventuality of any persons not turning up for sampling on the advice of Health authorities' intervention by Police shall be mandatory. Voilation of these orders shall attract action under Epidemic Diseases Act, 1897 and other relevant provisions of law.

This Order shall come into force and shall remain operative till further orders.
