ORDER

WHEREAS, Chief Secretary-cum-Chairman State Executive Committee (SEC) State of Himachal Pradesh vide his office order No. Rev(DMC)(C)20-2/2021-COVID-19-III dated 15-05-2021 has issued further directions to extend the restrictions from 6 AM of 17th May, 2021 to 6 AM of 26th May, 2021 with certain amendments.

NOW, THEREFORE, I K.C. Chaman, IAS, District Magistrate, Solan, District Solan do hereby order to extend the **Corona Curfew** w.e.f. **6 AM of 17th May, 2021 to 6 AM of 26th May, 2021** with the following amendments with respect to Order No. SLN/Reader/DM/1-14/89-IV 24381 dated 09th May, 2021:

1. Restriction placed on attendance of maximum 20 persons (**all present in the house**) in marriages shall be strictly followed; no marriage palace, community hall or tented accommodation shall be utilized for the purpose of marriage. It is further ordered that there will be complete restriction on use of outside catering, DJ/Band and procession of Barat. All marriages shall be performed inside homes. The organizers shall ensure that social distancing is maintained during the function. This order will come into force with immediate effect.
2. Hardware shops shall remain open on Tuesday and Friday from 08:00 AM to 11:00 AM only.
3. The Department of Excise & Taxation shall be allowed to function with minimum staff following all COVID-19 safety protocols.


