ORDER

This is with reference to this office order No. SLN/Reader/DM/1-14/89-IV-23620 dated 22nd April, 2021, whereby it has been ordered that the Employees State Insurance Corporation (ESIC) Model Hospital, Village Katha, Baddi, District Solan shall remain functional as Dedicated Covid Health Centre with full occupancy as per previous practice.

NOW, a request has been received from the office of the Chief Medical Officer, Solan vide letter No.HFW-SLN-Gen-(Misc)./2020-14446-49 dated 22.06.2021 vide which it has been intimated that services of DCHC ESIC Model Hospital Baddi, Village Katha as Dedicated COVID Health Centre is required to be released due to very less numbers of COVID-19 positive cases reported in District Solan.

NOW, THEREFORE, keeping in view the request and recommendation of the Chief Medical Officer, Solan, I, Kritika Kulhari, District Magistrate, Solan, do hereby order to release the E.S.I.C Model Hospital, Baddi, Village Katha as Dedicated Covid Health Centre except minimum 30 beds of ESIC Model Hospital for the management of COVID-19 cases, with the condition that same will be activated again in view of any future surge in COVID-19 cases.

This Order shall come into force with immediate effect till further orders.
