Qualification required	: A candidate must have a degree in Law of a recognized University and be enrolled as a advocate with the Bar Council of Tripura.
Eligibility	: A candidate must have practice on criminal side as an Advocate for not less than 3 years.

Terms and Condition

1. The candidate must submit ink signed original application within 5.30 PM on 31.07.2020 as per format alongwith self- attested copy of documents addressed to the DM & Collector, Dhalai District, Jawaharnagar. No application will be accepted after the stipulated period.
2. Each candidate should also produce original documents at the time of interview before the Selection Committee.
3. Incomplete and defective application in any form & containing incorrect information or suppression of facts will be summarily rejected without assigning any reason.
4. The date, venue and time of interview will be intimated to the individual applications through their e- mail.
5. The character and antecedents of selected candidates may be verified and if anything adverse is found, his/her candidature will be cancelled.
6. The candidate should submit the copies of judgment of at least 3(three) cases, in which the applicant has appeared & conducted before the competent court.
7. The Chairman, Selection Committee reserves the right to cancel or reject any application without assigning any reason, if found defective.
8. No TA/DA will be paid to the candidates for appearing at the time interview.
