

NOTICE INVITING TENDER

The Block Development Officer, Durgachowmuhan RD Block, Dhalai Tripura invites rates from bona fide agencies / persons in vehicle rental business for hiring of 1(one) "**Mahindra Bolero/Maruti Suzuki Baleno/Wagon R**" preferably white in colour, purchased not before the Calendar May, 2016 in good condition for 24 hours monitoring and supervision of MGNREGAS /PMA(Y(G) /SBM(G)/ Panchayat/ TRLM/ BADP/ Election/Disaster duty on the following terms & conditions:-

- 1) The rate should be quoted for detention charge is ~~as per~~ per day and run per kilometers in the form prescribed at **ANNEXURE-1**. Amount should be written both in figures and words.
- 2) The vehicle should have all valid documents as well as **commercial Registration & Certificate of Insurance** as per Motor vehicles Act.
- 3) The hiring of vehicles shall be valid for **1 (one) year** subject to extension of hiring on satisfactory service. However, the hiring may be discontinued by the undersigned at any time with a **short notice**.
- 4) The vehicle should be in very good condition for the sake of smooth & proper journey.
- 5) Providing fuel, lubricants, dusters and maintenance etc. for the vehicles will be the responsibility of the supplier.
- 6) The supplier will provide minimum accessories for the vehicle.
- 7) The driver should be given prescribed liveries by the supplier;
- 8) In case of need, the driver has to be changed within 24 hours of being informed and if the vehicle is not available on any day no payment (Halt age charge) would be made for the day and also for the next day;
- 9) In case of repairing of the said hired vehicle, a similar vehicle shall have to be provided by the supplier as replacement during the repair.
- 10) Payment of hiring charges will be on monthly basis against bill raised by the supplier supported by appropriate certificate from the user of the concerned office. **The highest sealing price is 29000/- (Twenty Nine Thousand) only per month.**
- 11) Tax will be deducted from the bill as per rules.
- 12) The concerned parties should have to submit PAN Card.
- 13) The vehicle shall be parked on in Government facilities for security reason.
- 14) **The tenderer will have to deposit an amount of Rs.5,000/- (Rupees five thousand) only as earnest money in the shape of Bank Draft / FDR / Deposit at Call drawn in favour of the Block Development Officer, Durgachowmuhan RD Block. The Tender will be treated as informal without earnest money. Earnest money will be refunded to the tenderer if the rates offered by him/her are not accepted and shall stand forfeited to the undersigned if the tenderer, on being asked to do so, fails to provide the vehicle within the stipulated time. The tender should be submitted in sealed cover duly superscripted as "Tender for hiring of vehicle ("Mahindra Bolero/Maruti Suzuki Baleno/WagonR")" addressed to the Block Development Officer, Durgachowmuhan RD Block only through Registered Post / Speed Post / Currier Service (Due to COVID-19 Pandemic situation) to reach to the address from 12/01/2022 to 28/01/2022 by 03:00 PM. The tender may be opened on 28/01/2022 at 04.00 PM in the office chamber of Undersigned, if possible.**
- 15) The undersigned reserves the right to reject the tender process or any rate including the lowest one without assigning any reason.
- 16) Whenever it become necessary, the vehicle need to travel anywhere within boundary of the state of Tripura.
