The stated sealed cover of the quotation should be captioned "**BED NET/Mosquito net**". Quotationer's full name and address with phone number should be mentioned on the envelope. The quotationer's may dropped their sealed quotations in the Tender Box kept in the Chamber of the BDO Ganganagar R.D.Block as per below mentioned format up to 3:00 pm on or before 29/01/2022 from the date of issue of this notification. Quotation tender box shall be opened at 4:00 PM on the last day of quotation dropping date. Quotationer or other authorized representative may remain present during opening of quotation. Quotations receive after stipulated date and time will be duly rejected.

Details of the same may be collected from the office of the Block Development Officer, Ganganagar R.D. Block from 10:00 am to 5:30 pm during office hour only.

Salient terms & conditions:-

1. The rates are inclusive of all taxes and charges.
2. Tender received after the scheduled date and hours shall be summarily rejected.
3. The office shall not be responsible for any postal delay.
4. No advance payment will be made. Payment will be made after proper receipt of the materials in good condition as per specification and properly certified by the Official/officer of this Block.

An amount of Rs. 10,000/- (Rupees Ten thousand) only as Earnest Money Deposit (EMD) is to be submitted through Demand Draft along with quotation in favour of **the Block Development Officer, Ganganagar R.D. Block, Dhalai Tripura** from any nationalized Bank payable at Ambassa otherwise the quotation will be deem as rejected. If the successful quotationer fails to provide the Mosquito net within the stipulated period the earnest money deposited along with the quotation will be forfeited. However the amount of earnest money of the successful bidder will be released on successful completion of delivery process. The earnest money of un-successful bidders will be released after 1(one) month from the date of opening of quotation.
6. No interest payable on the earnest money/security deposit.
7. The quotation may be cancelled at any time without any prior notice.
8. All pages of quotation including the blank pages should be signed by the bidder.
9. Necessary CST/TST(VAT) and IT will be deducted from the bill as per applicable rules.
