Major activities under taken by the District Hisar to control the spread of COVID-19

- RRT constituted at both District and Block Level
- Isolation ward established in GH Hisar, SDH Adampur & Hansi, CHC Barwala and Narnaund.
- Sufficient stock of logistics ie. PPE Kits, N-95 masks, VTM etc.
- Arrangement of pickup and drop of suspected COVID-19 persons.
- Sampling of COVID Suspects, Isolation, Contact Tracing , Quarantine activities carried out as per protocol.
- Sanitization of containment Zones and Houses of COVID-19 positive Cases.
- PPE kits being used by the RRT members
- COVID Ambulances available in district for the Referral of cases
- To ensure proper hand hygiene & use of mask by Health Workers
- Sensitization of Health Workers both District & Block level
- Advisory and self reporting format sent to PMO, all CHC/PHC/SDH, IMA, all Pvt. Hospitals
- IEC/BCC (Cough etiquettes, Hand Hygiene and Social Distancing by Health Workers in field (Toll Plaza, Bus Stand, Railway Station, Schools, Colleges, Villages)
- Established 24*7 control room no. 108, 94164-95690 at the District
- Intersectoral (DTF) Meeting of All Department regarding Containment Plan of COVID-19 under the Chairmanship of Hon'ble D.C. Hisar done.
- Sensitization of IMA, ESI, AMBULANCE Staff, Quarantine Facilities Staff, Session Court, DDPO, DPRO, Military Cantt., NRCE (Ghora Farm Dispensary M.O. and Nursing I/c)
- Mock Drill for Emergency response of handling of COVID-19 cases done in Civil Hospital, Hisar.
- The State govt. notified 'The Haryana Govt. Epidemic COVID-19 Regulations, 2020 under the Epidemic Disease Act 1897 on 11-3-2020

Major Activities undertaken by the State of Haryana to control the spread of COVID-19

• Department of Health fixed the per day upper cap of COVID treatment charges in all private hospitals through order dated 25.06.2020. The rates for isolation beds (Rs. 8, 000 per day for Non- NABH Hospitals, Rs. 10, 000 per day for JCI/ NABH Hospitals), ICU Beds without Ventilators (Rs. 13, 000 per day for Non- NABH Hospitals, Rs. 15, 000 per day for JCI/ NABH Hospitals), ICU Beds with Ventilators (Rs. 15, 000 per day for Non- NABH Hospitals, Rs. 18, 000 per day for JCI/ NABH Hospitals).

• State Government has fixed the Rates/ Charges for different type of COVID 19 testing as below: -

1. CBNAAT testing- 2400/-
2. True NAT Testing- 1250/-
3. Samples collected at private hospitals/ labs and their designated collection centers - 299/-
4. Samples collected through home visits - 499/-
5. Rapid Antigen Testing-350/-
6. IgG based ELISA Testing-250/-
