### DECLARATION

WHEREAS, it was Notified by Government in the Revenue Department vide Notification NO. F. 09 (04)-REV/ACQ/XVI/16 dated 02-05-2017, that the land/ lands described in the schedule hereto (hereafter referred to as the said land / lands) was / were needed or likely to be needed for the public purpose, namely for the purpose of construction of R C C Bridge approach road over river Khowai from Baganbazar to Santinagar road under Teliamura Sub-Division in Khowai District;

AND WHEREAS, the Government of Tripura is satisfied, on the basis of the observation made by Administrator of the concerned District that the Rehabilitation and Resettlement Scheme shall not apply, because no displacement of family / families will occur due to proposed acquisition process;

NOW, THEREFORE, it is hereby Declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said land / lands is / are required for the public purpose, namely for the purpose of construction of R C C Bridge approach road over river Khowai from Baganbazar to Santinagar road under Teliamura Sub-Division in Khowai District.

The Government is also pleased to direct the Collector, Khowai District under Section 20 of the said Act to proceed with the works.

The Land Statement and Plan may be inspected in the Office of the Collector, Khowai District during office hours.
