The sealed covered quotation will be received upto 03.00 p.m. in the office of the undersigned on or before 31-05-2021.

The sealed covered quotation will be opened in the same day i.e. on 31-05-2021 at 04.00 p.m., if possible.


The rate should be quoted as per prevailing market rate.

**The following terms and conditions are given below: -**

- (1) The Bidders/supplier should submit item wise quotation.
- (2) The supplier shall ensure to deliver the dry ration at the place to be intimated and the delivery charge shall be borne by the supplier.
- (3) The supplier shall maintain register for recording day to day supply of dry ration.
- (4) The supplier shall ensure to maintain hygiene in providing dry ration. The dry ration shall be supplied in the disposable packets and ensure the quality of dry ration to be supplied.
- (5) The undersigned reserves the rights either to accept or to reject any quotation even the highest or the lowest without assigning any reasons what so ever.
- (6) The supplier shall submit bills fortnightly in triplicate to this end along with token of the receipt and copy of register.
