The Block Dev.Officer, Puintala on behalf of Governor of Odisha invites percentage rate bid in sealed cover in conformity with detailed Tender Call Notice No: 01/Puintala/2018-19 to be eventually drawn up in State P.W.D. Form P-1 contract for the execution of works detailed in the table from eligible class of contractors mentioned against the work registered with the State Governments and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil works, on production of definite proof from the appropriate authority. The bidders may submit bid for the following work.

- Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the office of the undersigned during office hours every day except on Sundays and Public Holidays till last date of sale and receipt of tender papers. - Bid must be accompanied by bid security (EMD-1%) of the amount specified for the work in the table above in any one of the forms as specified in the bidding document i.e. N.S.C. / K.V.P. / Postal Saving Bank Accounts / Deposit receipt of Scheduled Bank(Valid minimum one year from the date of receipt) / Post Office Term Deposit Account duly pledged in favour of the Block. Dev. Officer, Puintala. Bids must also be accompanied by self attested Xerox copy of valid GST clearance, PAN card and valid contract registration certificate, up to date ITCC failing which the bid will be liable for rejection..
- The sale and receipt of the Bid document shall start from **Dt.07.01.2019 to 25.01.2019 during office hours except for last date. The sale of Bid documents for the last dt 25.01.2019 is up to 2.0 P M and receipt of the same is up to 4.00PM** in Panchayat Samiti Puintala and DRDA, Bolangir.
- Bid must be delivered in the tender box having mentioned as Tender Call Notice No. 01/ Puintala /2018-19 in Panchayat Samiti, Puintala and DRDA, Bolangir.

The bidders who have downloaded the bidding documents from the internet site will have to pay the cost of the tender document as indicated in col no. 5 of the above table in shape of demand draft/ bankers cheque in favour of **Block Dev. Officer, Puintala, payable at SBI Bolangir** in a separate envelope marked "**Cost of bidding documents down loaded from the internet**" with the bid document. Authority will not be held responsible, if any portion of the bid document is excluded or modified in the downloaded bid document.
- Bidding documents requested by mail will have to be dispatched by registered / speed post on payment of an extra amount of Rs. 500/- over the cost of documents. The undersigned will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
- The Bids will be opened on the **Dt. 28.01.2019 at 11.00AM** in the office of the undersigned, in the presence of the members of tender committee of Panchayat Samiti, Puintala ,bidders or their authorized agents who wish to attend at the Conference hall of Panchayat Samiti, Puintala If the office happens to be closed on the date of opening of the bids as specified the bids will be opened on the next working day at the same time and venue respectively. Other details can be seen in the bidding documents.
- Additional Performance Security shall be obtained from the successful bidder when the bid amount is less than the estimated cost put to tender. In such an event, the bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional performance Security (APS) in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the Block Development Officer, Puintala by the successful bidder
