Auction request received after the due date and time will not be entertained.
3. The Auction papers will be opened at 12.00 Noon of 18/07/2019 in the office chamber of the undersigned in presence of the bidders or their authorized representative(s).
4. The E.M.D. of ₹1000/- (Rupees One Thousand) only in shape of NSC/KVP/Postal Time Deposit/Bank TDR should be submitted duly pledged in favour of Additional District Magistrate, Nuapada with the tender documents.
5. The E.M.D. of unsuccessful bidders will be returned soon after completion of the auction process and EMD of successful bidder will be adjusted against the bid amount.
6. The amount should be reflected in words and figures prominently.
7. The interested persons may inspect the vehicle in the premises of the Collectorate, Nuapada during office hours on any working days from 9<sup>th</sup> July to 15<sup>th</sup> July 2019.
8. The highest bidder has to deposit 25% of the total bid amount immediately after finalization of the auction and the rest amount within 07 (Seven) days.
9. If the bidder fails to deposit the full amount within the prescribed time the total amount deposited by him will be forfeited and the vehicle will be put to fresh auction.
