Order No: 525 - FD of 2018 dated 07-12-2018 issued under endroement no. DP-15/CDS/2018-19/PS-901-I dated 07-12-2018 & Corrigendum to Govt. Order No. 525-FD of 2018 dated 07-12-2018 issued under endroement no: DP-15/CDS/2018-19/PS-901-I dated 01-01-2019 issued by the Finance Department.
- The expenditure is restricted to the allotted funds and no other liability is created.
- The Executing Agency shall install the sign board on the site of works.
- The Competent authority technically approves the works.
- The above works will be completed within one year from date of sanction.
- The works will be executed strictly as per the estimates sanctioned for the purpose.
- The location of the work are duly authorized by the concerned MLA.
- Codal formalities in the execution of the works shall be duly complied with.
- There should not be any sort of overlapping of funds from any other scheme without prior approval from this office.
- The local/public contribution, if any shall be properly accounted for while booking the expenditure.
- The works will be executed to the entire satisfaction of the intending Authority i.e (MLA/MLC) by the executing agencies shall be communicated to this office.
- A separate inventory of assets created under Constituency Development Scheme (MLA/MLC) by the executing agency shall be maintained.
- The accord of administrative approval of works shall be accorded by the concerned executing agency within his competence.**
- The monthly expenditure shall be furnished regularly by 5<sup>th</sup> of every month and saving in allotted amount, if any shall be communicated to this office.
- The Utilization Certificates after completion of works shall be furnished to this office with copy to the intending authority i.e. MLA/MLC.
- Un-utilized funds as may be available on 31st March, 2019 with executing agency shall be transferred to MH-8229 under intimation to this office for utilization in the following year making the Constituency Development funds non-lapse able.
- The work is/are new and not existing in State/District Plan/any other Programme/scheme for the current year/ previous five years.
- The work is/are beneficial for the community and is not for any individual benefits/any religious nature.
- The expenditure shall be debited to the Account Head MH- 3451- Secretariat Economic Services.
