

1. The funds shall be utilized for the approved works and no re- appropriation will be allowed without prior approval of the competent authority and adhere to the guidelines issued by the Government under the Constituency Development Scheme and revised accounting mechanism as detailed in Government order No. 111-F of 2001 dated 31-03-2001 issued by the Finance Department.
2. The expenditure is restricted to the allotted funds and no other liability is created.
3. The Executing Agency shall install the sign board on the site of works.
4. The Competent authorities technically approve the works.
5. The above works will be completed within one year from date of sanction.
6. The location of the works are duly authorized by the concerned MLA.

8. Codal formalities in the execution of the work shall be duly complied with.
9. There should not be any sort of overlapping of funds from any other scheme without prior approval from this office.
10. The local/public contribution, if any shall be properly accounted for while booking the expenditure.
11. The works shall be executed to the entire satisfaction of the intending Authority i.e (MLA/MLC) by the executing agencies shall be communicated to this office.
12. A separate inventory of assets created under Constituency Development Scheme (MLA/MLC) by the executing agency shall be maintained.
13. **The accord of administrative approval of works shall be accorded by the concerned executing agency within their competence.**
14. The monthly expenditure shall be furnished regularly by 5th of every month and saving in allotted amount, if any shall be communicated to this office.
15. The Utilization Certificates after completion of works shall be furnished to this office with copy to the intending authority i.e. MLA/MLC.
16. Un-utilized funds as may be available on 31st March, 2019 with executing agency shall be transferred to MH-8229 under intimation to this office for utilization in the following year making the Constituency Development funds non-lapse able.
