Subject:- Order under Section 144 of CrPC read with relevant provisions under Epidemic Diseases Act, 1897 and the Disaster Management Act, 2005 in connection with apprehended danger to human safety – regarding.

Reference: J&K Government Order No 49-JK(DMRRR) of 2020 dated 03/05/2020.

Whereas, the State Executive Committee of Department of Disaster Management, Relief Rehabilitation & Reconstruction vide **Government Order No 49- JK(DMRRR) of 2020 dated 03-05-2020**, has issued guidelines/ instructions, regulating activities within the Union Territory of Jammu and Kashmir for effective containment of COVID -19 w.e.f 4th May, 2020 till further order; and

Whereas, as per Para No. 3(IX) of the Annexure to the afore-mentioned Order, "**The Movement of Individuals for all non-essential activities between 7PM to & 7AM is a non- permissible activity requiring District Magistrates to issue specific prohibitory orders in this regard**".

Now, therefore, **I Om Parkash Bhagat ,KAS, District Magistrate, Kathua** vide powers conferred upon me under Section 144 of CrPC read with relevant provisions under the Epidemic Diseases Act, 1897 and the Disaster Management Act, 2005 do hereby restrict the movement of Individuals for all Non- Essential Activities between 7PM to 7AM in the territorial limits of District Kathua.

Since, it is not possible to serve prior notice of this order, it is as such being issued ex-parte. Any violation of this order shall invite punitive action under Section 188 of Indian Penal Code and other relevant sections of Epidemic Diseases Act, 1897 and the Disaster Management Act, 2005.

This order shall be widely circulated for information of all by the Director, Information and Public Relations.
