Order No 61 /MA

Date: 24-03-2020

In order to break the transmission chain of contagion of COVID-19, undersigned has issued prohibitory orders under section 144 of the Code of Criminal Procedure, 1973 vide endst. No. 4207-27/MA dated 23-3-2020 vide which restrictions on movement of any person outdoor (curfew) from 23-3-2020 (01:00PM) till further orders.

While in public interest some categories were exempted vide Order No 56/MA dt 23-3-2020 and Order No 59/MA dt 24-03-2020. These exemptions stand withdrawn with immediate effect. Now in supersession of the Order No 56 and 59, the following institutions/officers/employees/establishments are exempted from the restrictions of the curfew orders:

1. Indian Oil Corporation Limited, Sangrur
2. Bharat Petroleum Corporation Ltd. Sangrur
3. Hindustan Petroleum Corporation Ltd. Sangrur
4. Nayara Energy Limited formerly known as Essar Oil Limited and Reliance Industries Limited for uninterrupted supply of petrol, diesel to filling stations and related works.
5. Milk men and Dairy Owners for door to door delivery of milk between 5.00 am to 8.00 am only. They will not be allowed after 8.00 am in any case.
6. 2 shops per urban area will open on a rotation basis for door to door supply of medicines. Drug Inspector to notify the list for rotation basis.
7. Supply chain of vegetable and fruit delivery between 5.00 am to 7.00 am only. They will not be allowed after 7.00 am in any case. DMO and Secretary Market Committee will ensure supply of vegetables and fruits in the cities without overcrowding in mandis and that vegetables are supplied door to door in carts. They will also ensure that masks, gloves and other precautions are taken.
8. Critical Telecom Infrastructure including Telephone Exchanges, Mobile Switching Centres, Network Operation Centers, Transmission Centers, Data Centers, Telecom Tower sites, Call Centers of telecom service providers and warehouses where spares of telecom service providers are stored; including their manning, movement to and from these facilities of their staff.
9. Animal Husbandry and Veterinary Sector for emergent health situations provided that veterinarians and related officials maintain strict hygiene and sanitation measures as per guidelines.
10. Poultry/Animal feed and Dairy farms (including gaushalas) supply chain.
11. Electricity generation, transmission and distribution services and the uninterrupted supply of power.
12. ATMs of every bank (to ensure timely availability of cash). Cash Logistics/cash in transit CIT companies employees/ ATM maintenance personnel when on duty.
13. Water Supply and Sanitation/ Public Health Employees (Pump operators and Sewermen) for emergency maintenance services.
14. Sanitation staff of Urban Local Bodies between 6.00 am to 12.00 noon.
15. Door to door supply of LPG via Gas Agencies. DFSC to ensure operations as per orders.
16. Excise department employees and stakeholders involved in the process of allotment of vends for 28th and 29th March only.
17. Persons and vehicles involved in supply chain related to loading of rakes. DFSC/DM FCI to issue duty orders for the same to be produced in case of checking.




18. Cremation ground staff for all the cremation grounds of the district.
19. All Vehicles/persons in bona-fide transit (inter-state/inter district) shall be allowed to pass, but only after verification of point of origin and destination.

All exempted categories will also ensure that

1. Masks, gloves, handwashing and other precautions are taken as per guidelines.
2. Social Distancing is practiced during interaction with others


