The Sealed Quotation should be received by dropping in the quotation box kept in the office chamber of PD,DRDA,Jagatsinghpur during the office hours on working days only & the sealed quotations will be opened at 11.00 AM on dt.13.12.2018 in the office chamber of PD,DRDA, Jagatsinghpur. The bidders or their representative are required to be remain present at the time of opening of the quotation failing which no complain/dispute in future shall be entertained.

1. The quotation should be submitted in Sealed Cover addressed to Project Director, DRDA, Jagatsinghpur-754104. The words "Printing and fixing of Hoarding under Rural Housing" should be prominently written on the top of the envelope containing the quotation in capital letters only.
2. The quotation should be reached this Office latest by 5.00 pm on dt.12.12.2018.
3. Quotations will be opened on dt.13.12.2018 at 11.00 A.M.
4. The contract shall be comprehensive and no extra charges will be admissible. The successful bidders are to install the hoardings at Block HQ & District HQ as per requirement shown in Annexure-I
5. The order can be terminated by the Project Director, DRDA, Jagatsinghpur at any time without assigning any reason there of. If the work of the lowest quoted bidders is found to be unsatisfactory, The project Director, DRDA, Jagatsinghpur will be at liberty to entrust the same to the next lowest bidder. In this connection, the decision of the Project Director, DRDA,Jagatsinghpur shall be final and binding upon the bidder.
6. Payment will be made to the successful bidder upon completion of the work as per Govt. procedure & instruction by the designated authority.
7. Quotation received after due date and time will not be accepted.
8. The Project Director, DRDA, Jagatsinghpur reserves the right to reject any quotation in whole or in part without assigning any reason there of.
