### QUOTATION CALL NOTICE

Sealed quotation in plain paper/letter pad are invited from intended Registered firms/suppliers/agencies having valid GST Registration and I T Returns for **Webcasting** on daily hire basis for ensuing Bye-Election to Tirtol (SC) AC 2020.

The Quotation should be submitted in a sealed envelope superscribed in as "**Quotation for Webcasting**" containing the quotation and must be delivered to the District Election Office, Collectorate, Jagatsinghpur on or before **21.10.2020 by 1.00 P.M.** through Registered Post / Speed Post of Indian Postal Deptt. or dropped in the assigned box at the District Election Office, Collectorate, Jagatsinghpur. The quotation received after the stipulated date & time shall not be entertained. The quotations will be opened on the same day at **3.00 P.M.** in the office chamber of the Addl. District Magistrate, Jagatsinghpur. Quotationers or their authorized agents may remain present at the time of opening of Quotation.

### TERMS AND CONDITIONS OF THE QUOTATION CALL NOTICE.

- (1) The Intending Quotationer must be bonafied registered body having valid GST Registration No. and IT return. Self attested photo copy of the GST registration certificate and IT return should be attached.
- (2) The Intending Quotationer should have valid PAN Card. Self attested photo copy of PAN Card should be attached.
- (3) The Supplying Agency must not have been blacklisted by any Govt. organization. (Attach declaration in Stamp Paper of Rupees Ten).
- (4) The successful bidder should be ready to supply and perform webcasting within 02 (Two) days from the date of receipt of supply order.
- (5) All the materials will have to be installed at designated location in their own cost. The transportation, loading, unloading charges will not be paid.
- (6) The quotationer **shall deposit non-interest bearing earnest money of Rs.5,000/- (Rupees Five thousand) only** in shape of Account Payee Draft payable to the Collector and District Election Officer, Jagatsinghpur which will be refunded to the unsuccessful quotationer or whose quotations are not accepted. The EMD of the successful quotationer will be refunded after completion of the validity period.
- (7) If any dispute arises, the matter shall be referred to purchase committee for settlement of dispute.
- (8) The quotations received in incomplete form or after the scheduled date & time shall be summarily rejected.
- (9) Failure to supply the order in full within the stipulated period from the date of issue of supply order amounts to cancellation of order automatically.
- (10) The authority reserves the right to reject any or all the quotations without assigning any reason thereof and shall bear no liability what so ever consequent upon such decision




