In exercise of the powers delegated vide G.O.Ms.No.47/F3/2014, dt. 09.12.2014 of the Finance Department, Puducherry, sanction is hereby accorded for incurring of an expenditure to the tune of ₹16,80,000/- (Rupees Sixteen lakh and eighty thousand Only) towards granting of financial assistance to 50 family members belonging to Below Poverty Line in the Union Territory of Puducherry in the event of natural/unnatural death of their family members between the age group of 18-60 years under the Rajiv Gandhi Social Security Scheme for Poor Families 2012 as detailed in the Annexure appended herewith.

2. The Financial assistance to 50 Nos. of beneficiaries listed in Form-C under reference 2nd cited above shall be paid through 'ECS' to the bank accounts maintained by the beneficiaries in the respective nationalized/scheduled banks in the Union Territory of Puducherry.

The expenditure is debitable to the head of account, "2235-Social Security and Welfare-60 Other Social Security and Welfare Programme-60/101(01)-Group Personal Accident Insurance Scheme for Below Poverty Line family members (02)-Karaikal Region-(50)-Other Charges (Revenue Head)" in the Budget of the current financial year.
