PROHIBITORY ORDERS ISSUED UNDER SECTION 144 Cr.Pc.

Whereas the Hon'ble Supreme Court of India in its Order in a Special Leave to Appeal (Civil) No.8519/2006 , dated 12-01-2013,has directed that "Henceforth, State Government shall not grant any permission for installation of any statue or construction of any structure in public roads, pavements, sideways and other public utility places".

2. Whereas it has been made to appear to me by the report furnished by the Assistant Director (Survey and Land Records),Branch Survey Office, Karaikal that a statue has been installed in the land located at RS.No.122/3pt of the Neravy Revenue village which is classified as a GP-Pathway in the revenue recordas . Further, a portion of the statue also falls in Rs.No. 123/11pt for which no permission has been obtained from the authorities concerned .

3. Whereas the Commissioner, Commune Panchayat, Neravy has made it clear in his report that the commune Panchayat "U" drain adjacent to the Statue has been illegally closed without prior permission .

4. Whereas the Superintendent of Police, Karaikal (South) has made it clear in his report that the installation of a statue in the land located at RS.No.122/3 of the Neravy Revenue village would lead to competitive statue building which may lead to disturbance of public peace , tranquility and communal harmony .

5. Whereas having considered all the information placed before this court, I am fully satisfied that the situation prevailing in the Neravy Revenue village within the jurisdiction of this court requires , invoking of provisions as contained U/s.144 Cr.Pc.

6. Now, therefore, in exercise of powers as conferred on, by the provisions as contained U/s.144 Cr.Pc, I , M. ADHARSH, Sub-Divisional Magistrate of Karaikal make the following written orders for strict compliance by the general public that :-

(i) There shall be no activity involving installation, inauguration, construction and garlanding of any statue in public places situated in NERAVY Commune Panchayat. Government functions ,religious functions and other functions with the express approval of the Government shall be exempted from this clause.

(ii) There shall be no new construction of statues of National / Public Personalities in public or private places. In case of construction of statues in private places , prior approval of the District Magistrate has to be obtained.

(iii) There shall be no unlawful gathering of four or more persons in violation of this order in the area under the jurisdiction of this Court.

(iv) Any member of the public found to violate this order shall be punished U/s.188 of IPC.

(v) This order comes into force with immediate effect.

As the Notice cannot be served individually on all concerned, the Order is passed ex parte. This shall be published for the information of the public by affixing copies on the Notice board and all the offices located within the Neravy Commune Panchayat, including every public places,
