ORDER FOR THE REMOVAL OF NUISANCE

(U/S 133,134 &135 Cr. P.C.)

Whereas, the menace caused by the stray pigs noted to be moving around the residential areas by and large in and around the Karaikal District , is presently high. Complaints have been received from various sections of people like farmers, gardeners , residents of lay outs, shop keepers, road users motorists, that fatal road accidents, have been caused by the stray pigs interrupting vehicular traffic in Karaikal. Extensive damage to the crops, plantations have been reported by the farmers which needs immediate corrective and preventive action. Health hazardous effects like spread of filth caused by the pigs in the slushy land, which will promote breeding of mosquitos, which may cause the spread of diseases like Malaria which is identified as one of the major challenges to public health.

2. Whereas, the nuisance caused by the stray pigs needs to be checked and stopped once for all for which Pig rearing in Karaikal District has to be regulated by the authorities of Local Bodies Karaikal Municipality, and all other commune Panchayats of Kottucherry, Nedungadu, ,Neravy , T.R.Pattinam&Thirunallar. Hence this court is satisfied that under the prevailing conditions as placed evidently before this court , it is necessary to impose the provisions of sections 133,134,&135 of Cr.Pc to curb the nuisance caused by the Stray Pig menace in Karaikal District .

3. Hence, I , M.ADHARSH, Sub -Divisional Magistrate, Karaikal doth hereby pass the following orders to be executed by the stake holders concerned :-

a.) All Pig rearers in Karaikal District are to be brought registered by the Local Bodies (Municipality and Commune Panchayat concerned ) and they are to be sensitized towards the sanitation aspects of pig rearing. The pig rearers are to maintain their Pigs in their own encircled yards specially meant for the same purpose. On the occurrence of any default on the part of the pig rearers, found causing straying of their Pigs or causing damage to public health, immediate confiscation of their animals must be effected and such animals may be disposed off as per the provisions of applicable Local Body Act and Rules.

b.) The Local Bodies are hereby instructed to seize any pig found straying in public places.

c.) All Station House Officers of Police Stations in Karaikal District are to provide the adequate protective arrangements to their area of jurisdiction to the Local Body teams engaged in the anti stray Pig activities as and when requested by the Commissioners of the Municipality or Commune Panchayat concerned .

This order is passed as an ex-parte order by this Court since the counter petitioners could not be physically mustered before this court and the issue concerned is of urgent in nature, hence such an order is passed by this court.
