Sub: DCK – Novel Corona Virus – Mechanisms of Tracing issued by
National Disaster Management Authority, Govt. of India – Reg.
Ref: No. 1-137/2018-Mit.II(FTS-10548), dt. 17.03.2020.

In the wake of the Novel Corona Virus (COVID19) situation which has been declared as a notified disaster under the provision of Disaster Management Act, 2005, the District Administration is taking several preventive measures.

Considering the public health, it is imminent to impose various restrictions under the Epidemic Diseases Act, 1897 to prevent the spread of Novel Corona Virus. Accordingly, the following instructions are issued.

1. The General Public / foreigners who have arrived to Karaikal District from 01.01.2020 should voluntarily contact the District Control room at District Collector Office, Karaikal for ensuring follow up on their well being.
2. Special clinics (Corona Clinics) have been set-up at the Govt. General Hospital, Karaikal with screening facilities for such persons as per the protocol prescribed to by the Ministry of Health, Govt. of India.
3. The follow-up of the said persons would be taken-up by the field level Health Officials of concerned Primary Health Centres of Karaikal District.
