'Veterinary Services at Your Doorsteps'

Novel Corona Virus (COVID19) situation has been declared as a notified disaster under the provision of Disaster Management Act, 2005, and various restrictions are imposed under the Epidemic Diseases Act, 1897 to prevent its spread. The District Administration is taking various measures to prevent its spread, while ensuring maintenance of essential services and supplies, including health infrastructure.
