In exercise of the powers delegated vide G.O.Ms.No.47/F3/2014, dt. 09.12.2014 of the Finance Department, Puducherry, sanction is hereby accorded for incurring of an expenditure to the tune of ₹17,25,000/- (Rupees Seventeen lakh and twenty-five thousand Only) towards granting of financial assistance to 50 family members belonging to Below Poverty Line in the Union Territory of Puducherry in the event of natural/unnatural death of their family members between the age group of 18-60 years under the Rajiv Gandhi Social Security Scheme for Poor Families 2012 as detailed in the Annexure appended herewith.

The expenditure is debitable to the head of account, "2235-Social Security and Welfare-60 Other Social Security and Welfare Programme- 60/101 – Personal accident Insurance Scheme for Poor families - 60/101(01)-Group Personal Accident Insurance Scheme for Below Poverty Line family members – 60/101(01)(02)-Karaikal Region-(50)-Other Charges (Revenue Head)" in the Vote on Account 2020-21.


