**ORDER**

Sub: DCK - DM - COVID-19 -Lock Down Measures beyond 31.05.2020 -  
Phased re-opening of prohibited activities - Reg.

The Novel Corona Virus Disease (nCOVID-19) situation has been declared as a notified disaster under the provision of Disaster Management Act, 2005, and various orders and instructions are issued by the District Administration to contain its spread.

2. Now, in pursuance of the order No. 40-3/2020-DM-I(A) dt. 30.05.2020 of Ministry of Home Affairs, Government of India, lockdown measures will continue to be implemented in containment zones of Karaikal District upto 30.06.2020 and the prohibited activities will be re-opened in a phased manner in areas outside Containment Zones. The Karaikal beach is open for general public use subject to adhering to the following directives for COVID-19 management.

1. Wearing of face cover is compulsory.
2. Spitting in public places shall be punishable with fine, as may be prescribed in accordance with its laws, rules or regulations by the UT / Local Authority.
3. Social distancing shall be followed by all persons in public places and in transport.
4. Consumption of liquor, paan, gutka, tobacco etc in public places is strictly prohibited.
5. Shops will ensure minimum six feet distance among customers and shall not allow more than 5 persons at the shops.
6. Parking of two wheelers / cars strictly should be in parking area only with adequate physical distancing.
7. Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years are advised to stay at home.
8. Beach Park shall be closed.
9. No contact games or coaching shall be held.
10. Assembling in Groups of more than 5 persons / Large gatherings are not allowed.

3. All activities shall be consistent with the Government guidelines regarding health, social distancing and hygiene. The Municipal authorities shall sanitise the public places periodically.

4. Any person violating these measures will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Section 188 of the IPC and other legal provisions as applicable.
