Sub: Implementation of Rajiv Gandhi Social Security Scheme for Poor Families 2012 - Expenditure Sanction - Issued.

In exercise of the powers delegated vide G.O.Ms.No.47/F3/2014, dt. 09.12.2014 of the Finance Department, Puducherry, sanction is hereby accorded for incurring of an expenditure to the tune of ₹9.60.000/- (Rupees Nine lakh and sixty thousand Only) towards granting of financial assistance to 32 family members belonging to Below Poverty Line in the Union Territory of Puducherry in the event of natural/unnatural death of their family members between the age group of 18-60 years under the Rajiv Gandhi Social Security Scheme for Poor Families 2012 as detailed in the Annexure appended herewith.

The expenditure is debit to the head of account, "2235-Social Security and Welfare-60 Other Social Security and Welfare Programme- 60/101 - Personal accident Insurance Scheme for Poor families - 60/101(01)-Group Personal Accident Insurance Scheme for Below Poverty Line family members - 60/101(01)(02)-Karaikal Region-(50)-Other Charges (Revenue Head)" in the Budget.
