NOTIFICATION

In exercise of the powers conferred by the provision to article 309 of the Constitution of India, read with the Notification No.F.5/4/65-GP, dated 11th January 1965 of the Ministry of Home Affairs, Government of India, New Delhi the Lieutenant Governor, Union Territory of Puducherry, hereby makes the following rules regulating the method of recruitment to the post of Sub Inspector of Fisheries (SGIA in the Karaikal Krishi Vigyan Kendra Society, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Karaikal Krishi Vigyan Kendra Society- Sub Inspector of Fisheries Recruitment Rules, 2020.

(2) They shall come into force on and from the date of their publication in the official gazette.

2. **Number of post, its classification and Pay Band and Grade Pay.**-The number of the said post, its classification and the Pay Band and Grade Pay attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed hereto.

3. **Method of recruitment, age limit and other qualifications.**-The method of recruitment to the said post, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.

4. **Disqualification.**-No person,-

- (a) who has entered into or contracted a marriage with a person having a spouse living ;
or
(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post :

Provided that the Governing Body of the Karaikal Krishi Vigyan Kendra Society, may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax.**-Where the Governing Body of the Karaikal Krishi Vigyan Kendra Society, is of the opinion, that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. **Saving.**-Nothing in these rules shall affect the reservations, relaxation in upper age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.

DRAFT RECRUITMENT RULES FOR THE POST OF SUB INSPECTOR OF FISHERIES

1. Name of the post : Sub Inspector of Fisheries
2. Number of post : 1 (One) [2020]
Subject to variation dependent on work load
3. Classification : Group 'C'
4. Pay Band & Grade Pay / Level in Pay Matrix : PB-1: Rs.5200-20200+Grade Pay Rs.2800
5. Whether selection post or non-selection post : Not applicable.
6. Age limit for direct recruits : Not exceeding 30 years (Relaxable for Government servants up to 40 years in accordance with the instructions or orders issued by the Central Government, provided such Government Servants are working for not less than 3 years in posts which are in the same line or allied cadres and a where relationship can be established that the services rendered by them in the Department will be useful for efficient discharge of duties in the post for which selection is made)
- : **Note-1** In case of recruitment made through Employment Exchange, the crucial date for determining the age limit shall, in each case, be the last date upto which the Employment Exchanges are asked to submit the names.
- Note-2** In the case of recruitment made through advertisement, the crucial date for determining the age limit shall be the closing date for receipt of application.
7. Educational and other qualifications required for Absorption/ Deputation/direct recruits : **Essential qualification :**
A Bachelor's in Degree in Fisheries Science/ Fisheries Technology/Zoology from a recognized University.
8. Whether age and educational qualification prescribed for direct recruits will apply in the case of promotes : Not applicable
9. Period of Probation, if any : Two years.
10. Method of Recruitment whether by direct recruitment or by promotion or by deputation/transfer and percentage of the vacancies to be filled by various methods : By Direct recruitment
Note: Vacancies caused by the incumbent being away on deputation or long illness or study leave or under other circumstance for a duration of one year or more may be filled on deputation basis from officials of Puducherry Administration
a. holding analogous posts on regular basis; and
b. possessing the qualification prescribed for direct recruits under column.7
