ORDER

In the wake of the Novel Corona Virus (COVID19) situation, which has been declared as a notified disaster under the provision of Disaster Management Act, 2005, the District Administration is taking several preventive measures.

As per the instructions issued by the Secretary (Health), Chief Secretariat (Health), Puducherry vide Ins. No. 1089/Secy(Health)/PS/2021, dt. 09.04.2021, the following activities are to be executed by the Departments concerned in Karaikal District.

1. Wearing of mask is an essential preventive measure and is compulsory in public places. Greater co-ordination is needed among the line departments especially among the Health, Revenue, Police Department and Local Bodies to promote COVID-19 appropriate behaviour in work places and in public, especially in crowded places to stop the emerging second wave of Corona. All the line departments to ensure strict wearing of face covers / masks and follow Covid appropriate behaviour at all public places. In order to enforce this core requirement, the line departments may implement administrative action, including imposition of appropriate fines, on persons not wearing face masks in public and work spaces.

2. Observance of social distancing in crowded places, especially in markets, weekly bazars and public transport, is critical for containing the spread of infection. Sufficient number of hand sanitisers with dispensers to be kept at all shops and strict enforcement of Covid appropriate behaviour is to be followed at all places.

3. Corona Curfew from 12.00 Midnight till 05.00 AM.

[Action: SSP, DC(R), DC(DM)]

4. Industries are permitted to function by strictly following the Standard Operating Procedure (SOP) already issued by Government. Industrial establishments shall arrange for the vaccination of their employees based on the guidelines issued by Government of India from time to time and stern action would be initiated against the industries and organisations in case of violation of SOP.

[Action: Labour Officer, Inspector of Factories]

5. Cinemas / Theatres / Multi-plexes shall be permitted to function with 50% of the seating capacity by following the SOP issued already.

[Action: SSP, DC(R), DD(LA), Commissioners of all Local Bodies]

6. Following the SOP (no entry for general public without mask) restaurants, food courts and tea shops shall be permitted to operate till 11.00 PM with 50% of seating capacity. Take away (parcel) will be permitted upto 11.00 PM. Recreation clubs shall be permitted to function with 50% seating capacity.

[Action: SSP, DC(DM), DD(LA), Commissioners of all Local Bodies]

7. All social / political / academic / entertainment / sports / cultural and other functions shall be permitted in closed spaces after duly following the SOP of social distancing, masking and sanitisers.

[Action: SSP, CEO, DD(SE)]

8. All religious places / places of worship shall be permitted for public worships till 08.00 PM by strictly following the SOP.

[Action: DC(DM), EO(Temples)]

9. Rental vehicles and taxis including cab aggregation shall be permitted to ply with three passengers excluding the driver. However there shall be strict enforcement of restriction imposed on the number of passengers.


[Action: SSP, DC(DM), RTO]

10. Autos shall be permitted to ply with two passengers excluding drivers. However, there shall be strict enforcement of the restriction imposed on the number of passengers.

[Action: SSP, DC(DM), RTO]

11. Public transport especially buses shall be permitted for the available seat capacity only. No passengers are allowed extra. Sanitisation at the entry point must be facilitated.

[Action: SSP, DC(DM), RTO]
