## Preliminary Notification

Whereas it appears to the District Collector, Prakasam District, Ongole that the lands specified in the schedule below are needed for a public purpose by Port authorities i.e., A.P Maritime Board, Kakinada for establishment of Non-Major Port of Ramayapatnam at **Ravuru** village **Gudlur** Mandal, notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of section 11(1) of the Right to fair compensation and Transparency in land acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013).

As per Section 10 (A) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Andhra Pradesh) Amendment) Act 22 of 2018 as Amended to the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 30 of 2013 has exempted for conduct of SIA for acquisition of Land for establishment of Non-Major Port of Ramayapatnam at Ravuru village Gudlur Mandal.

There are no families likely to be displaced due to land acquisition.

Now, therefore in exercise of the powers conferred under section-12 of the Act, the District Collector, Prakasam District, Ongole hereby designates the Sub-Collector, Kandukur his staff and workmen to exercise the powers conferred under the above said section and to enter upon and survey land, take levels of any land, for proper execution of their work as provided and specified in section 12 of the said Act.

Under Section 11(4) of the Act, No person shall make any Transaction of cause any transaction of land i.e., sale / purchase etc, or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector, Prakasam District, Ongole/Sub-Collector, Kandukur.

Objection to the acquisition if any may be filed by the person interested within 60 (sixty days) from the date of Publication of this notification as provided under section 15 of the Act before the Sub-Collector, Kandukur/District Collector, Prakasam District, Ongole.

A plan of the land may be inspected in the office of the District Collector, Prakasam District, Ongole and Sub-Collector's Office, Kandukur on any working days.

There-fore it is notified that for the above said project in **Ravuru** village **Gudlur** Mandal Prakasam District a piece of land measuring more or less Ac.80.25 cents wise 32-48 hectors of standard the above of measurement, whose detail description is as following is under acquisition.
