Subject:- Containment and Management of COVID-19 spread.

ORDER NO 37- CZ OF 2021

DATED 29.04.2021

Whereas more than Thirty Covid-19 positive cases have been reported from Mehjoor Nagar area of Srinagar city in past three days, developing into a cluster.

Whereas we apprehend that the Covid-19 positive patients in the said cluster might have come in contact with many other persons in the area and there are chances of further transmission of the deadly virus in the locality and its surroundings, and

Whereas in order to break further transmission of Covid-19 in the area and its surroundings, it is felt expedient to take stringent measures by restricting movement of people and other activities in and around its surroundings.

Therefore, In view of the above, I, **Mohammad Aijaz (IAS)**, District Magistrate, Srinagar in exercise of powers vested in me under Section 34 of Disaster Management Act 2005, and Section 144 of CrPC do hereby order that:

1. The area covered under location namely **Mehjoor Nagar Tehsil Chanapora** shall be containment zone. There shall be no inward or outward movement of any person from/to the said area. In case the spread of clusters goes beyond 300 mtr, the committee headed by Administrator of the containment zone (Tehsildar) may decide boundary of containment zone
2. The Tehsildar concerned namely **Mr. Imran (Cell No. 7006575236)** shall be the administrator of the Containment Zone. He shall coordinate with all the line departments to ensure the availability of all basic requirements including Food grains, LPG medicines etc in the Containment Zones.
3. CMO Srinagar should activate the Rapid Response Teams (RRTs) immediately for survey and surveillance in the area besides line listing and contact tracing.
4. The Commissioner SMC shall depute teams immediately to sanitize the Containment zone and the exercise shall be repeated as per SOP. He shall submit daily Action Taken report for perusal of Chairman DDMA.
5. The SSP Srinagar shall ensure that all entry/ Exit points in the Containment zone are sealed, other than one designated entry/exit for exigencies/emergency and restrictions on movement of the people in the containment zone are affected in letter and spirit as per SOPs. He shall deploy requisite number of personnel to man the entry/exit points.
6. Any person / group/institution found violating the directions of this order shall be booked under relevant act/ rule/ law.

Accordingly the containment zone shall be managed and contained by committee of following officials/officers who shall be responsible for implementing SOPs/above directions.

1	Tehsildar	Administrator of Containment Zone	Overall Incharge
2	Executive Eng. (PWD), and he may nominate representative.	Member	Barricading
3	Station House Officer (SHO)	Member	Entry Exit Control
4	Tehsil Supply Officer(TSO)/ Supervisor	Member	Providing of door step ration and other necessary food items
5	Ward Officer SMC	Member	Sanitization
6	Medical Officer to be nominated by concerned ZMO	Member	Surveillance, RRT, Sampling, Vaccination etc

The committee under supervision of Tehsildar shall be responsible for management and containment of zone. Administrator should ensure that announcements are made inside containment zone for restricting movement and implementation of SOPs. It shall be also ensured that all basic requirements of population are provided at their doorsteps for which administrator can involve any employee of any department within his jurisdiction.

Tehsildar to establish 24*7 control room meant exclusively for Containment Zone.

Sub Divisional Magistrates (SDMs) shall be responsible for overall monitoring and supervision and shall ensure teams work in coordinated manner.
