**e-Tender Notice for Supply and Installation of Furnitures of Godrej Company in 10 Courts Building in Sub-Divisional Civil Courts at Manjhaul (Begusarai)**

Office of the District & Sessions Judge, Begusarai at Begusarai invites e-Tender from original equipment manufacturer/Firm/Authorised dealer to supply and install eight different types of furnitures of Godrej Company in the newly constructed 10 Courts Building in Sub-Divisional Civil Courts, at Manjhaul under Begusarai Judgeship.

- Sealed tender in two parts i.e. Technical Bid and Financial Bid are hereby invited from original equipment manufacturer/ firm/ authorised dealer till **1:30 PM on 18.03.2020 at the office of the District & Sessions Judge, Begusarai.**
- Minimum eligibility criteria are as below:-
- Company/firm/agency should have at least one year experience of operating such establishment.
- Company/firm/agency's turnover should be minimum of Rs. 50,00,000/- ( Fifty lakh only) per annum ( 2018-2019)
- Earnest money of Rs. 1,00,000/- ( One lakh) is to be paid along with the technical bid through D.D. in favour of District & Sessions Judge, payable at Begusarai.
- Company/firm/agency must provide photo copy of Pan Card.
- The original equipment manufacturer/firm/authorised dealer shall submit catalogue/brochure of the furniture along with the technical bid. Samples of the models quoted in the bid shall be made available at the opening of tender for assessing product quality as per the laid down specifications in the tender document. Only the product qualified thereon shall be considered for financial evaluation.
- Tender document may be **purchased till 4:30 PM on 17.03.2020.**
- The Tender will be received in the office of District & Sessions Judge, Begusarai till **1:30 PM on 18-03-2020.** The tender shall be opened on the same day at **4:35 PM** in which the tenderer of its representative may remain present.
- **Cost of tender document:-**

However, it has to be physically purchased form the office of District & Sessions Judge, Begusarai by payment of Rs. 100/- ( One Hundred only) in cash. Agency will have to submit tender through hand only in the same serially numbered tender document.
