Notification

In exercise of the powers vested in me under section 115,116 and 117 of the Motor Vehicles Act 1988, I, Madan Chauhan IAS District Magistrate Distt. Hamirpur do hereby declare the following places of Hamirpur town as no parking/parking places as per proposal received from the Sub Divisional Officer © Hamirpur:-

1. Entire road between ICICI Bank to District Hospital will be the no parking zone except parking already marked in front of CMO office gate for taxis.
2. Small space available outside boys school ground will be used for parking of twenty numbers of two wheelers and yellow line will be marked accordingly.
3. Loading/unloading timing for goods between Bhota chowk and Naduan chowk shall be allowed between 8 PM to 8 AM only.
4. Main market road from Gandhi Chowk to Hosptial chowk shall be closed for all type of vehicles except emergency services from 5:30 PM to 6:30 PM and other restriction as applicable shall be continued. Chain be affixed outside Roshan Jeweller Shop, Sabzi Market and Ayurvedic Hospital to restrict the entry of vehicle completely during no entry time.
5. Naduan Chowk area shall be a tow away zone.
6. (1) Yellow lines will be marked for stopping of buses for boarding-deboarding of passengers at the following places.
 - (i) Dosarka Chowk .
 - (ii) Both side of Bhota Chowk.
 - (iii) Near Mridul Chowk .
 - (iv) Near Shiv Mandir Chowk, Anu.
 - (v) Anu Degree College near main Gate.
- (2) Yellow line will be marked at Dosarka near Sabzi Mandi for LMV goods carrier for temporary stoppage.
- (3) Yellow line will also be marked for parking of two wheelers only in front of Govt. Degree college employees parking Gate to Akashwani.
7. Road from Bhota Chowk to Naduan Chowk and Nadaan Chowk to Mridul Chowk shall be the parking area.
8. Vehicles between police line Gate Dosarka to Salig Marriage Palace shall be parked only on one side of road i.e. opposite of hill side across the road.
9. No Trucks/Tractors shall ply on the road between Dosarka Chowk to Hamir Hotel and Trade Union between 8 A.M. to 8 P.M. .

10. No vehicles shall be parked on road between HPSEB Rest House to Children Park.
11. No vehicles shall be parked on the left side of road leading to Hira Nagar/Circuit House Via Dang Kwali between old SDM Office Chowk to DFO Office Hamirpur.
12. No vehicles shall be parked on any side of road at T-Point formed at the end of Dang Kwali on the road coming from Pucca Bharow to Anu.
