ORDER

In exercise of power vested in me under clause 2 (g) of the Himachal Pradesh Epidemic (COVID-19), Regulation, 2020.I, Harikesh Meena, IAS , District Magistrate, Hamirpur do hereby appoint following public servants/officials as Surveillance Personal:-

1. All the Gram Panchayat/Pradhan of District Hamirpur within their respective jurisdiction.
2. All the Panchayat Secretaries / Sahayaks of the District Hamirpur within their respective jurisdiction.


The above Surveillance Personal will have following rules and responsibilities:-

1. Sub-divisions shall ensure adequate arrangements of temporary shelters, and provision of food etc. for the poor and needy people, including migrant laborers, stranded due to lockdown measures in their respective area;
2. The migrant people, who have moved out to reach their home/home town must be kept in the nearest shelter in the respective Sub-division's quarantine facilities after proper screening.
3. Ensure that each and every individual with foreign travel and outside state travels history is identified and entered in the database already prepared for the same. If anyone is left out he/she is immediately captured in the database through concerned BDO.
4. To keep a strict eye and vigilance on the persons with foreign travels history or history of people with travels history outside state, and ensure that they are adhering to strict home quarantine.
5. To ensure that any person on entering the Panchayat area from outside the country or state be put under home quarantine and captured in the Database.
6. Keep track of the persons who are visiting outside the state on account of any other reason and ensure that they maintain proper protection against COVID-19 and maintain strict home quarantine on entering the Panchayat area.
7. Immediately inform the concerned SDM or BDO in case of the above category develops symptoms of COVID-19.
8. Inform the concerned SDM if any violation of the curfew order is committed by any person within the Panchayat area.
