**ORDER UNDER SECTION 144 Cr. P.C.**

In modification of this Office Order No- 1513/DCH/Relief/DM/2020 dated 18<sup>th</sup> April, 2020 and in continuation of this Office Order No- 1870/DCH/Relief/DM/2020 dated 23<sup>rd</sup> April, 2020 issued by the undersigned regarding redefining of the Containment Zones in District Hamirpur, it is hereby ordered as here under:

Whereas, two cases of COVID-19 were found positive in the District Hamirpur and MC Hamirpur (all 11 wards), Gram Panchayats-Bajuri, Daruhi & Anu in Sub-Division Hamirpur and Jol-Sappar, Rangas & Bonni Panchayats of Sub-Division Nadaun of this District were sealed to contain spread of CoronaVirus (COVID-19).

And whereas, no case of COVID-19 has been detected or identified during this period of containment, even after Active Case Finding Campaign, and as informed by Chief Medical Officer, Hamirpur, no positive case of COVID-19 has been traced and that a period of 14 days has been elapsed since the detection of the cases in the above mentioned areas. All the Primary & Secondary contacts have been followed and not even a single case has been detected as positive. Therefore, the containment of aforementioned areas of MC and Gram Panchayats is not required to be continued as such.

Now, Therefore, I, Harikesh Meena (IAS), District Magistrate, Hamirpur (H.P) do hereby order that MC Hamirpur (all 11 wards), Gram Panchayats-Bajuri, Daruhi & Anu in Sub-Division Hamirpur and Jol-Sappar, Rangas & Bonni Panchayats of Sub-Division Nadaun shall no longer be sealed and are hereby denotified as containment zone . All the relaxations given by vide this Office Order No 1870/DCH/Relief/DM/2020 dated 23<sup>rd</sup> April, 2020 and 1949/DCH/Relief/DM/2020 dated 26<sup>th</sup> April, 2020 and prior to the declaration as containment zone shall be applicable to the entire District Hamirpur till further.


This order shall come into effect immediately from 1<sup>st</sup> May, 2020 for the entire area of District Hamirpur. However, the Curfew/Lockdown shall remain in force till further orders.
