## ORDER

In view of Government of Himachal Pradesh Revenue Department-Disaster Management Cell Order No. Rev (DMC) (C) 20-2/2020-COVID-19 dated 14/06/2020 it hereby ordered that;

- 1) Persons covered under SOPs issued vide dated 23<sup>rd</sup> May 2020 for Inter-State movement of industrial workers, industrialists/factory owners, traders, raw material suppliers, service providers inspecting authorities will be exempted from purview of Home Quarantine.
- 2) The persons visiting the State for bonafide purpose of trade, business, job, project, service purpose, commission agents and arthiyas with supporting documents and entering the State with valid permit/ E-Pass and not coming from high COVID-19 case load cities and other containment zones from rest of the country will also be exempted from the purview of quarantine.
- 3) The management, incharge or head of any NGO or any charitable organization, which has branches in the State, and travels to the State of Himachal Pradesh in connection with its affairs or for an official meeting, for a short duration not exceeding 48 hours and don't mix with general masses, follows all social distancing and other COVID-19 prevention protocols/ norms, does not organize any social/ cultural or any other gathering of any sort, shall be exempt from quarantine requirement in the State.
- 4) In addition to the instructions in the original Order, use of Aarogya Setu Application shall be mandatory in all cases, including the above exempted categories.

In addition to the above, this Office order No. DCH-Relief/DM Cell/-6067 dated 2<sup>nd</sup> June 2020 is partially modified as follows;

S.No.	Category of Persons	Type of Quarantine	Period of Quarantine
8.	Labour brought from other States by Orchardists/ Agriculturists/ Contractors/ Project Proponents	"The migrant labourers coming in the State can be sent directly to the work site of orchardist/ Agriculturist/ Contractor/ Project Proponents. The labour can start working at these sites immediately subject to observing all the due precautions including social distancing/ isolation and the constant monitoring for symptoms, as is being done for quarantined persons. The period of active surveillance shall however continue to the same as per the period prescribed by the guidelines issued by the Department of Health & Family Welfare."	NA


In view of the Government of Himachal Pradesh order Rev (DMC) (C) 20-2/2020-COVID-19 dated 14/06/2020 it is further ordered that;

"All persons coming from high case load COVID-19 infected cities will be institutionally quarantined. Only for exceptional and compelling reasons such as cases of human distress, pregnancy, death in family, serious illness, persons above 65 years of age with co-morbidities and parent (s) accompanied by children below 10 years may be permitted to be home quarantined, instead of Institutional Quarantine, for 14 days, subject to satisfaction of the concerned District Magistrate about satisfactory arrangements being available for such Home Quarantine."

However, in the above mentioned cases, the concerned SDMs may obtain a certificate from the concerned Gram Panchayats certifying that satisfactory arrangements for Home Quarantine are available before permitting Home Quarantine.

This order shall come into force with immediate effect.


