**OFFICE ORDER**

WHEREAS, one positive case of Covid-19 was detected in Naya Nagar.W.No.08, Municipal Council, Hamirpur Tehsil Hamirpur, Sub Divison Hamirpur, District Hamirpur HP and another case was detected in Village Bathroom, Gram Panchayat Bhadroon, Tehsil Nadaun, Sub Divison Nadaun, District Hamirpur HP, and accordingly following areas were declared as Containment Zone vide Order NO./DCH/RELIEF/DM/2020-6178 dated 06/06/2020.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby **denotified as a containment zone** All the relaxations given vide this Office Order No./DCH/RELIEF/DM/2020-1870 dated 23/04/2020 and Office Order NO./DCH/RELIEF/DM/2020-1949 dated 26/04/2020 and other subsequent orders issued in this regard shall now be applicable in the above mentioned areas as well.

This order shall come into force with immediate effect.


