OFFICE ORDER

Whereas one positive case of Covid-19 was detected in Village Techh, Gram Panchayat Dandroo in Tehsil & Sub- Division Barsar, District Hamirpur HP, and in order to contain the spread of COVID-19, the following areas of Sub-Division Barsar were declared as Containment Zone vide Order NO./DCH/RELIEF/DM/2020-6162 dated 05/06/2020.

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during this period of Containment even after the Active Case Finding Campaign and as such Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone. All the relaxations given vide this Office Order No./DCH/RELIEF/DM/2020-1870 dated 23/04/2020 and Office Order NO./DCH/RELIEF/DM/2020-1949 dated 26/04/2020 and other subsequent orders issued in this regard shall now be applicable in the above mentioned areas as well.

This order shall come into force with immediate effect.


