ORDER UNDER SECTION 144 Cr. P.C.

WHEREAS, it has been brought to the notice of the undersigned by the Health Authorities of District Hamirpur that Covid-19 Cases have been detected in the following areas of District Hamirpur:

1. Three positive cases in W.No.01, Village Sai, Gram Panchayat Hathol, Tehsil Nadaun District Hamirpur H.P.
2. One positive case in Village Sukriah Uppreli, W.No.02, P.O. Sansooh, Gram Panchayat Behrar, Sub-Tehsil Kangoo, District Hamirpur H.P.
3. One positive case in Village Nanot W.No.01, Gram Panchayat Uhal, Tehsil Bamson at Tauni Devi, District Hamirpur H.P.
4. One positive case in Village Kot, W.No. 06, Gram Panchayat Mahal, Tehsil Bhoranj, District Hamirpur H.P.

Therefore, keeping in view the aforesaid facts and circumstances, I, Harikesh Meena (IAS) District Magistrate, Hamirpur (Himachal Pradesh) in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, do hereby order complete sealing of the areas of Containment Zone shown below:

Sub-Division	Gram Panchayat	Containment Zone
Nadaun	Hathol	➤ Village Sai, Ward No. 01 Area restricted to Right side of Bhidu road (Gwalpathar to Hathol).
	Behrar	➤ Village Sukriah Uppreli, W.No.02
Hamirpur	Uhal	➤ Village Nanot W.No.01
Bhoranj	Mahal	➤ Village Kot, W.No. 06

It is further ordered that under no circumstances ingress/egress of any person or vehicle, except officers/officials/vehicles on Government duty, to this area shall be allowed. Further, now there shall be no relaxation in **CURFEW** imposed qua any shops or banks within the entire area as described above till further orders. The home delivery of all the essential goods like milk, groceries, fruits, vegetables, pharamceutical, gas supply shall be made through the Administration.

No person shall leave their homes or move on foot or by vehicle or travel or roam around or stand on any road or public place in the afore mentioned areas of the respective Panchayats till futher orders.

This order shall come into force with immediate effect.
