## ORDER

WHEREAS one positive case of COVID-19 was detected in W.No. 1, Village Ganoh-Brahamna, Gram Panchayat Dhabriana, Tehsil Barsar, one in W.No. 2, Village Gori, Gram Panchayat Kathiana, Tehsil Dhatwal at Bijhri, Sub-Division Barsar, three in Village Manwin, Gram Panchayat Lagmanwin, Tehsil Bhoranj and one in Village Droberi, P.O Himmer, Tehsil Tauni Devi, Sub-Division Bhoranj, District Hamirpur HP and in order to contain the spread of COVID-19, the following area of Sub-Division Barsar & Bhoranj were detected as Containment Zone vide Order No. DCH/Relief/DM/2020/-6562 (A) dated 25/06/2020.



And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign and such Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.
