ORDER

WHEREAS, prohibitory orders under Section 144 of Code of Criminal Procedure, 1973 were passed by the undersigned vide this office no. DCH/Relief/DM/2020-598 dated 24.03.2020 in the entire District of Hamirpur for containment & spread of COVID-19 and was further extended vide order no. DCH/Relief/DM/2020-5269 (A) dated 24.05.2020.


WHEREAS, the Additional Chief Secretary (Home) to the Government of Himachal Pradesh, vide notification no. Home (A) A (9)-12/2020 dated 30.6.2020, has conveyed the authorization of the Governor of Himachal Pradesh to the undersigned to extend the period of aforesaid order further up to 31.07.2020.

Now therefore, I, Harikesh Meena, IAS, District Magistrate, Hamirpur in pursuance of notification no. Home (A) A (9)-12/2020 dated 30.6.2020 of Additional Chief Secretary (Home) to the Government of Himachal Pradesh and in exercise of power vested in me under Section 144 of the Cr. P.C., do hereby extend the period of Prohibitory Order passed on 24.05.2020 and subsequent orders till further orders in the entire territorial area of district Hamirpur with the modification that movement of individuals shall remain strictly prohibited between 9:00 PM to 5:00 AM, except for essential activities.

Violation of this order shall attract provisions of Section 188, 269 & 270 of IPC and all other relevant provisions of law and the violators shall be prosecuted accordingly.

These orders shall come into force with immediate effect in the entire District of Hamirpur.
