**ORDER UNDER SECTION 144 Cr.P.C.**

WHEREAS, it has been brought to the notice of the undersigned by the health authorities of Sub Division Barsar, District Hamirpur that Covid-19 cases have been detected in the following areas of Sub Division Barsar, District Hamirpur:-

1. Three positive cases in Ward No.-2 and 4 of village and PO Bijhari Gram Panchayat Bijhari Tehsil Dhatwal at Bijhari District Hamirpur.

Therefore, keeping in view the aforesaid facts and circumstances, I, Pradeep Kumar, H.A.S., Sub Divisional Magistrate, Barsar District Hamirpur, HP in exercise of the power vested in me under section 144 of the Code of Criminal Procedure do hereby order complete sealing of the areas of containment zone shown as below:-

Sub Division	Gram Panchayat	Containment Zone
Barsar	Bijhari	Ward No.-2 Sankhyan Gali from house of Shri Sukhdev Sankhyan to old CDPO office building underneath the link road towards Lakhoh.
		Ward No.-4 from opposite side of Panchayat Ghar below road upto the house of Shri Om Prakash.

It is further order that under no circumstances ingress/egress of any person or vehicle except officers/officials /vehicles on Government duties, to this area shall be allowed. Further, now there shall be no relaxation in CURFEW imposed qua any shops or banks within the entire area as described above till further orders. The home delivery of all essential goods like milk, groceries, fruits, vegetables, pharmaceuticals, gas supply shall be made through the administration.

No person shall leave their homes or move on foot or by vehicle or travel or roam around or stand on any roads or public place in the aforementioned areas of the respective panchayats till further orders. This order shall come into force with immediate effect.
