ORDER UNDER SECTION 144 Cr. P.C.

WHEREAS, it has been brought to the notice of the undersigned by the Health Authorities of District Hamirpur that four positive cases of Covid-19 have been detected in the following areas of District Hamirpur HP.

1. Two Positive cases in Village Bateral Upperli , Ward No. 01, Gram Panchayat Jeoli Devi & in Village Akarana, Ward No. 01, Gram Panchayat Kalouhan, Sub Divison Barsar, District Hamirpur HP.
2. One Positive case in Ward No. 08, Village Mundkhar Tulsi, Gram Panchayat Mundkhar, Sub Divison Bhoranj, District Hamirpur HP.
3. One Postive case in Ward No. 05, Village Badehar, Gram Panchayat Badehar, Sub Divison Bhoranj, District Hamirpur HP.

Thus, there is an imminent risk of spreading of COVID-19 in the surrounding areas which may result in sudden hike in corona cases in the district.Hence, strict measures are the urgent need of the hour to prevent the spreading of this disease which if not taken immediately, can pose grave danger to the lives, health and safety of the residents of the area.

Therefore, keeping in view the aforesaid facts and circumstances, I, Harikesh Meena (IAS) District Magistrate, Hamirpur (Himachal Pradesh) in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, do hereby order complete sealing of the areas shown below:

Barsar	Jeoli Devi	Left side of Jeoli Devi link road (From Sh. Ranjit Singh's house to Sh. Vishan Dass's house) Village Bateral Upperli (Ward No. 01)
	Kalouhan	Right side of Akarana-Ghumarwin-Salauni road (from house of Smt. Onkar Devi to house of sh. Ashok Kumar) Village Akarana, (Ward No. 01)
Bhoranj	Mundkhar	Ward No. 08, Village Mundkhar Tulsi, Partially Khatuan Bas from the house of Sh. Kishori Lal and Sh. Nand Lal house to house of Sh. Jagdish Chand
	Badehar	Ward No. 05, Village Badehar (From the house of Sh. Jagan Nath S/o Barfa Ram to house of Sh. Balwant Singh S/o Fhounu Ram)

It is further ordered that under no circumcumstances ingress/egress of any person or vehicle, except officers/officials/vehicles on Government duty, to this area shall be allowed . Further, now there shall be no relaxation in CURFEW imposed qua any shops or banks within the entire area as described above till further orders. The home delievery of all the essential goods like milk, groceries, fruits, vegetables, pharamceutical, gas supply shall be done through the Administration.

No person shall leave their homes or move on foot or by vehicle or travel or roam around or stand on any road or public place in afore mentioned areas of the respective Panchayats till futher orders.

This order shall come into force with immediate effect.
