ORDER

WHEREAS one positive case of COVID-19 was detected in Village & PO Bairi, Gram Panchayat Pahlu, Tehsil & Sub Divison Barsar, District Hamirpur HP and one positive case was detected in Ward No. 02, MC Hamirpur, Sub Division & District Hamirpur and in order to contain the spread of COVID-19, the following area of Sub-Division Barsar & Hamirpur was declared as Containment Zone vide Order No. DCH/Relief/DM/2020/-7166 dated 05/08/2020.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.

This order shall come into force with immediate effect.
