ORDER

WHEREAS one positive case of COVID-19 was detected in Hamlet Bhorladda of Village Chandel, Ward No. 04, Gram Panchayat Jajri, Sub Divison Barsar, District Hamirpur HP, one positive case was detected in Ward No. 01, Village Dhanwi, Gram Panchayat Aghar, Sub Division, District Hamirpur & one positive case in Ward No. 05, MC Area, Sub Division & District Hamirpur and in order to contain the spread of COVID-19, the following areas of Sub-Division Barsar & Hamirpur were declared as Containment Zone vide Order No. DCH/Relief/DM/2020/-7208 dated 10/08/2020.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.

This order shall come into force with immediate effect.
