ORDER

WHEREAS one positive case of COVID-19 was detected in Village Dakeda, Gram Panchayat Darviar, Sub Division Hamirpur, one positive case in Village Jangal, Gram Panchayat Putriyal, Sub Division Nadaun, one positive case in Village Gauna, Gram Panchayat Gauna, Sub Division Nadaun, one positive case in Village Bholi Bhan, Gram Panchayat Batran, Sub Division Nadaun, District Hamirpur HP and in order to contain the spread of COVID-19, the following areas of Sub-Division Hamirpur & Nadaun were declared as Containment Zone vide Order No. DCH/Relief/DM/2020/-7252 dated 16/08/2020.

Sub-Division	Gram Panchayat	Containment Zone
Hamirpur	Darviar	Ward No. 01, Village Dakeda (06 household from Cowshed of Vijay Kumar to house of Leela Devi)
Nadaun	Putriyal	Ward No. 02, Putriyal (area retracted from Balh Chowk to boundary of Village Jangal)
	Gauna	Ward No. 02, Village Gauna (area restricted to the left side of link road Gauna, starting from GSSS Gauna Karour to house of Raman Sharma)
	Batran	Ward No. 03, Village Bholi Bhan (area restricted to the left side of Bholi Bhan link road)

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.

This order shall come into force with immediate effect.
