ORDER

WHEREAS four positive cases of COVID-19 were detected in Village- Baterali Upperli , Gram Panchyat- Jeoli Devi and Village - Akarana ,Gram Panchayat- Kalouhan, Sub Division –Barsar & in Village- Mundkhar , Gram Panchayat- Mundkhar & in Village- Badehar , Gram Panchayat – Badehar , Sub Division- Bhoranj in order to contain spread of COVID -19, the following areas were declared as Containment Zone vide Order No- DCH/RELIEF/DMC/7267 dated 17.08.2020.

	Kalouhan	➤ Right Side of Akarana- Ghumarwin – Salouni Road(from House of smt. Onkar Devi to House of Kishori Lal and Nand lal House to House of Sh. Jagdish Chand)
Bhoranj	Mundkhar	➤ Ward no 08 Village- Mundkhar Tulsi, Partially Khatuan Bas from the house of Sh. Kishori Lal and Sh. Nand lal house to house of Jagdish Chand.
	Badehar	➤ Ward no 05, VillageBadehar (from house of Sh. Jagan Nath S/o Barfa Ram to house of Sh. Balwant singh S/o Fhounu Ram)

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the peroid of Containment even after the Active Case Finding Campaign and such Containment of above mentioned areas is not required to be continue as such./

Therefore, I, Harikesh Meena (I.A.S) District Magistrate do hereby ordered that all the above mentioned areas shall no longer be sealed and hereby **denotified as Containment Zone.**
