## ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 03, Village Ghaleda, Gram Panchayat Tikkar Bhula, Sub Division Hamirpur, one positive case in Ward No. 07, Village Matlana Gram Panchayat Samirpur, Sub Division Hamirpur, one positive case in Ward No. 02, Village Jijwin, Gram Panchayat Badhani, Sub Division Bhoranj, District Hamirpur HP and in order to contain the spread of COVID-19, the following areas of Sub-Division Hamirpur & Bhoranj were declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-7332 dated 25/08/2020.

And whereas no new case of COVID-19 has been detected or identified in the above mentioned areas during the period of Containment even after the Active Case Finding Campaign, and Containment of the above mentioned areas is not required to be continued as such.

Therefore, I, Harikesh Meena (IAS), District Magistrate Hamirpur do hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.
