ORDER

WHEREAS one positive case of COVID-19 was detected in Ward No. 01 & Ward No 02, Village Bharin Gram Panchayat Kale Amb, Sub Divison Hamirpur, one positive case in Ward No. 03, Village Kakkar, Gram Panchayat Kakkar, Sub Divison Hamirpur, one positive case in Ward No. 05, Village Ghorlamber, Gram Panchayat Bherda, Sub Divison Hamirpur, one positive case in Ward No. 08, MC Area, Sub Divison Hamirpur, one positive case in Ward No. 05, Village Kot Rasedwan, Gram Panchayat Paplah, Sub Divison Bhoranj, one positive case in Ward No. 02, Village Lajhyani, Gram Panchayat Ludder Mahadev, Sub Divison Bhoranj, one positive case in Ward No. 05, Gram Panchayat Pansai, Sub Divison Nadaun, one positive case in Ward No. 07, Gram Panchayat Lahra, Sub Divison Nadaun, one positive case in Ward No -05 (Bela), Gram Panchayat Bela, Sub Divison Nadaun & District Hamirpur HP and in order to contain the spread of COVID-19, the following areas of Sub-Division Barsar was declared as Containment Zone vide Order No. DCH/Relief/DMC/2020/-7378 dated 28/08/2020.

Therefore, hereby ordered that all the above mentioned areas shall no longer be sealed and are hereby denotified as Containment Zone.
